Job Posting: Occupational Therapist in Beautiful Northern BC

Job Description:

We are looking for an Occupational Therapist (OT) to join our dynamic, multi-disciplinary team. This individual would work with children from birth to kindergarten entry through our Early Intervention program as well as with children and youth aged 6-18 through our School-Aged therapy contract. Using a family-centered approach, the OT provides consultation, assessment, intervention and monitoring in the areas of self-care, productivity and leisure. Competitive wage and benefits offered. Mentorship and opportunities for continuing education are provided.

This is a permanent, full-time, sole-charge position (35 hours per week). Kitimat is a town of 8000 people located on the northwest coast of BC. The community is known for its small-town friendliness and easy access to outdoor activities.

Duties and Responsibilities

- Provide therapy services to children with a variety of special needs
- Conduct assessments of children's cognitive/behavioural/psycho-social and motor development as it relates to function using standardized and informal assessments, interviews and clinical observation.
- Plan, implement, monitor, evaluate and revise therapy programs. Areas of specialization include, but are not limited to, seating and positioning, equipment prescription, sensory integration, sensory processing and feeding.
- Work in conjunction with families and caregivers to implement therapy goals and programs. Provide training regarding occupational therapy needs.
- Ensure adherence to standard work practice and the accredited Policies and Procedures of the organization as well as CARF accredited standards
- Collaborate and maintain a positive and professional relationship with clients and their families, all members of the organization's staff, and community partners
- Function as an effective member of various multidisciplinary teams. Consult with and facilitate community awareness and network building with schools, medical staff, public health, and other community agencies
- Provide documentation in the form of charting and report writing as per professional standards and the policies of the Kitimat CDC
- Maintain service statistics as per the policy of the Kitimat CDC.
